Mr. Larry Bennett is on the Faculty of the University of Illinois at Chicago, Jane Addams College of Social Work, Chicago, IL. Mr. Bennett will discuss the relationship between substance abuse & domestic violence, exploring the risk factors & treatment considerations associated with both. Mr. Bennett will present thought provoking issues to assist in more effectively holding batterers accountable for their behaviors as well as getting substance abusers the services that they need.

This training is for Batterer Intervention Service Providers, Substance Abuse Service Providers, Probation Officers, Victim Advocates, Clergy, Medical and Judicial Personnel & other related professionals. Participants will gain an increased understanding of the connection between Domestic Violence and Substance Abuse as well as tools for practical application.

DIRECTIONS

From Detroit/ Ann Arbor: Take 94 west to 52. Go south on 52 into Adrian. West on W. Maumee St. South on N. Madison St. West on Williams St. (From Ann Arbor it is shorter to take 12 west to 52 and continue as above, just as previously written.)

From Grand Rapids: Take 96 east to Lansing. Go south on 127. East on 94 to 127 S. (Exit 142). Follow 127 south. Go east on U.S. 223 into Adrian. East on W. Maumee. South on N. Madison St. West on Williams St.

From Lansing: Go south on 127. East on 94 to 127 S. (Exit 142) Take 127 south. East on U.S. 223 into Adrian. East on W. Maumee. South on N. Madison St. West on Williams St.

From Jackson: Go south on 127. East on U. S. 223 into Adrian. East on W. Maumee. South on N. Madison St. West on Williams St.

From Hillsdale: East on 34. North on M 52 (N. Main St). West on W. Maumee St. South on N. Madison St. West on Williams St.

From Monroe: West on M-50. South on M-52. West on W. Maumee St. South on N. Madison St. West on Williams St.
